

# PRESENTATION OF KEYNOTE PAPER ON THE OVERVIEW OF THE NIGERIA BIOECONOMY FRAMEWORK BY PROF. KEN IFE, THE PROJECT CONSULTANT, FMFBNP AND MD/CEO OF BISOURCES & TECHNOLOGY LIMITED

The Technical paper highlighting the framework, components, and designed activities to achieve the new Economy for Nigeria.

He elaborated the importance of Bio-Economic activities to Nigeria critical sectors including Agriculture/Forestry, Pharmaceuticals, Foods & beverages, consumer goods, Energy, Chemical Industry, Textile/Clothing, Building Industry and Mechanical Engineering as all key areas that will benefit and contribute to the Bio-Economic activities of Nigeria.

He gave scenario where the over 21million Cassava peels (representing 25%) from the over 65million tons of cassava majorly seen as waste material in many rural communities could produce several millions tonnage of livestock. "We shall convert our waste to wealth, reduce our carbon footprint, create jobs for our youths, earn foreign currencies from our export activities through the project, and if Germany can earn 2.4Trillion Euros from Bio-Economic activities, it

means Nigeria can do better and the journey begins with this project" he concluded.



# PLENARY SESSIONS ON STATE GOVERNMENT INTERVENTION IN CASSAVA VALUE CHAIN

Critical Stakeholders selected to include the President of ALL Farmers Association of Nigeria, Alh. Farouk Kabir, ADAN President-Prof. O.J Jayeoba, Acting HOD, Macro Economic Analysis, FMFBNP Mr. Felix Okonkwo and Representative of College of Forestry and Mechanization, Engr. Oladele Olugbenga (Moderator).

The Plenary Session was a very fruitful engaging moment of the workshop where the stakeholders and the participants shared their views, experiences, observations all geared towards ensuring the success of the Nigeria Bio-Economy Programme and the Cassava Bioethanol Pilot Project. Various issues on Location of Pilot projects, Farm Market Assurance, Farm Input support to Farmers were extensively discussed to ensure that the Project Team take note of the critical points and ensure timely delivery of inputs, subsidy provisions where necessary. There are series of questions and answers by the participants and Panelist to seeks clarifications and the session ended with everyone being satisfied with the outcome.



# SYNDICATE GROUP DISCUSSIONS ON THE CRITICAL COMPONENTS OF THE PROJECT

The excess of the Syndicate group work was to share with participants the key designs and structure of the project and to get their contributions to ensuring a hitch free implementation.

**Syndicate Group 1:** Hybrid Cassava Foundation Seed Multiplication (TME 419/Obasanjo/Hope) and Cassava

Chair: Prof. N.I Odiaka

Rapporteur: Ogirinye Innocent

#### **Key Recommendations**

#### 1. Seed Selection:

- Awareness Creation and Sensitization needs to be intensified.
- Specialized Seed Multiplication clusters should be organized and trained to carry out community Seed multiplication.
- Further capacity strengthening should be organized for the Extension personnel for further step down and support to farmers.
- Organic seeds should be promoted in the production systems.
- Need to carry out awareness on cassava varieties and especially the ones for the project TME 419, Hope and Obasanjo 2

#### 2. Seed Propagation/Planting

- Farmers should be trained how best to cut their stems.
- More training of farmers on Cassava Production systems

#### 3. Inputs Distribution Timeline

- Fresh stems should be supplied and delivered timely.
- The Production start period of June-August in the Northwest region must be considered.

#### 4. Mechanization

- Specialized and dedicated Mechanization Service Model should be established for the Project in the region and targeted at the Cassava Clusters in the Zone
- More Tractors should be deployed for the project.
- A Cluster should be grouped by 50 hectares of land for cluster production of Cassava.

#### 5. Cassava Grow-Out

- Farmers should be trained on Early Disease control measures.
- Quality Weed control chemicals should be supplied.
- Mechanized Cassava Weeders should be provided.
- Efforts should be made to reduce or eliminate middlemen in the farm Inputs supply chain.
- There is a need to establish mechanism to check quality of Fertilizers and Agro-Chemical to reduce the incidences of adulteration.
- Granulated Organic fertilizer should be promoted.
- Farm Inputs Subsidies should be promoted by Govt.

#### 6. Cassava Harvest

- Simple mechanized Cassava Harvesters should be promoted and deployed for the project.
- Such Harvesters should be subsidized by the Government and Key Promoters of Cassava Value chain Projects.

#### 7. Marketing

- Contract Farming Arrangements should be put in place.
- Farmers should be linked Directly to processors and supported to carry our direct trading.
- Guaranteed Minimum Price (GMP) for Cassava should be established.
- Multiple Produce Taxation should be eliminated.



# Syndicate Group 2: Cassava Value Chain Processing

#### **Key recommendations**

- Project should ensure provision of Regional Cassava Conditioning Rooms to cushion the effects of any transportation related Issues after harvest.
- Strategic Support funds should be put in place to support existing processors of Cassava and to encourage entrant of new

processors.

• Government should develop Bilateral relations with countries that uses cassava heavily to create new market opportunities for Nigeria.

#### SYNDICATE GROUP 3: Bio-Entrepreneurship

#### **Key Recommendations:**

- Inculcate the Love for skill acquisition at Primary School Level (cognitive Knowledge)
- Step the Skill/knowledge acquisition level to be affirmative at the Secondary school level.
- At Tertiary Level Knowledge and Skill acquisition at this level should be Psycho-motive
- Curriculum development should be based on KPI.
- Project and Risk Management should be included in the curriculum.
- Step by Step Policy Implementation should be carried out through Monitoring & Evaluation processes.
- Research, Development, Innovation & Commercialization processes should be well defined.
- Include 1% of project budget and dedicate it to Research and Development Activities
- Promote Mechanization/Technology adoption as critical component of the Curriculum and the project.





SYNDICATE GROUP 4: INNOVATION CHALLENGE FUND AND DEVELOPMENT FINANCE INTERVENTION

#### **Key recommendations**

- Securities such as guarantor, the family members of the applicant should be able to guarantee him/her.
- The introduction of BDSPs (Business development service providers) has helped a lot in document. The BDSPs tend to package the right documents to be forwarded to the Bank. The also provide business advice to the Customers.
- Enlightenment on good record keeping. Farmers should be enlightened on the importance of keeping record to make it easy for them in securing finances from the Bank.
- Interest free Loan should be introduced by the Banks.
- Farmers should be encouraged to form Associations to enable them to have the support of financial innovations. As we all know two heads are better than one.
- A tripartite agreement should be established between the Bank, supplier, and the owner of the business. This will cushion the disagreement encountered during disbursement.
- Provision/sourcing of off takers that can buy the products. Off takers should be made available for the products of the farmers to encourage more farming. It is of no use for a farmer after harvesting his products, the product should be laying idle without any one to buy them thereby leading to loss on the part of the farmer. A specific Company should be put in place in which farmers after harvesting, they deliver to the Company, and they should receive value for the products instantly.
- Adequate monitoring of the activities of the beneficiaries by the Bank to prevent the diversion of funds.
- For falsification of membership, Search is to be conducted as Corporate Affairs Commission and Ministry of Corporative to determine the authenticity of the members.
